Drugs Control Administration, Telangana seized <u>overpriced</u> medicine, 'CYLET-2.5 Tablets' (Letrozole Tablets IP 2.5 mg), primarily used in the treatment of breast cancer. The tablets were manufactured by Stepan Life Sciences Pvt Ltd., Haryana – The MRP indicated is significantly higher compared to the Ceiling Price fixed for the product by the Central Government.

The details are as follows:

Drugs Control Administration officials seized **'CYLET-2.5 Tablets'** (Letrozole Tablets IP 2.5 mg) during the raids conducted on 6th April, 2024.

The product Letrozole Tablets IP 2.5 mg sold under brand name 'CYLET-2.5 Tablets' is under price control as per the Drugs (Prices Control) Order, 2013 and the price of the product shall be in accordance with the 'Ceiling Price' fixed by the National Pharmaceutical Pricing Authority (NPPA), Government of India.

The product 'CYLET-2.5 Tablets' (Letrozole Tablets IP 2.5 mg) of Batch No. SHT-204-2, Mfg. Date: Nov-2023, Exp. Date: Oct-2025, Manufactured by: Stepan Life Sciences Pvt Ltd., Plot No. 184, Sector - 6, IMT Manesar, Gurugram, Haryana, Marketed by: Cynak Life Sciences, (A Division of Cynak Healthcare), Plot No. 463, Cabin 2, HSIIDC Indl. Area, Rai – 131029, Distt. Sonipat, Haryana, **bears** <u>MRP as Rs. 199/- for 5 tablets</u> on the label of the product which is a violation of the Drugs (Prices Control) Order, 2013. The <u>Ceiling price fixed by the Central Government</u> including Wholesale Price Index (WPI) for the product "Letrozole Tablets IP 2.5 mg" is **Rs 29.32 per one tablet (Ceiling Price).**

Hence Maximum Retail Price (MRP) i.e. including GST 12 % should not be more than **Rs. 32.84 per one tablet i.e., Rs. 164.2 per strip of 5 tablets** (MRP=Ceiling Price+GST)

The firm overpriced the product. Firm charged <u>excess of Rs. 34.80/- per</u> <u>strip of 5 tablets</u> which is a violation of the **Drugs (Prices Control) Order, 2013.**

Stocks of the medicines were seized during the raid conducted at a medical shop in Nalgonda.

Sri. K. Someshwar, Drugs Inspector, Nalgonda and Sri. G. Surender, Drugs Inspector, Suryapet are among the officers who carried out the raid.

Further investigation shall be carried out and action shall be taken as per the law against all the offenders.

The prices of Essential Medicines shall be in accordance with the Ceiling Prices fixed by the Central Government. Overpricing of essential medicines is a violation under the Drugs (Prices Control) Order, 2013, and stringent action shall be taken as per the law against violators.
